5. General understanding of the local context and geographical area is an added advantage
6. The supplier or the vendor should tax clearance Government revenue office.

### Other cancellation clause

If any conditions, in the invitation to tender or the supplier's application, change within the stated period, an additional Letter of Agreement must be agreed and signed by both parties.
